

## VEHICLE USE LICENCE RULES

### THE RULES

**THESE RULES ARE INCORPORATED IN THE LICENCE IN THEIR ENTIRETY AND GOVERN THE USE OF THE VEHICLE UNDER THE USE**

#### **WARNING**

*Using a motor vehicle for any purpose is inherently dangerous and life-changing injury or death can result as well as damage to property. The Vehicle may have been built before modern safety features governing its handling and braking capabilities were adopted and its interior may comprise many hard surfaces and projections which could cause injury if in contact with its occupants. The performance, safety and comfort of a modern vehicle should not be expected and the Vehicle must be driven with special care and attention to allow for its much lower capabilities and an almost complete absence of safety features in the interests of its occupants and any bystanders or the users of other vehicles.*

#### **1.0 BACKGROUND**

- 1.1 The Vehicle is of a certain age.
- 1.2 As such it has limited performance and protections in every way in comparison to a modern car.
- 1.3 The Hirer must have regard to those limitations at all times when using the Vehicle.
- 1.4 In general, the Vehicle must not be used except in a manner consistent with the safe and considerate use of a similar car on a public highway in the United Kingdom.
- 1.5 The Hirer must ensure that the description of use provided to the Insurer matches that in the Licence agreement.

#### **2.0 RULES REGARDING THE USE**

- 2.1 The Vehicle must not be used except in a manner which is outlined in the Licence Agreement.
- 2.2 The Vehicle must not be overloaded at any time.
- 2.3 The Vehicle must not carry more persons than there are seats in it.
- 2.4 Where seat belts are fitted, those belts must be worn by occupants when the Vehicle is moving.
- 2.5 The Vehicle must not be driven at a speed beyond the speed rating of the tyres fitted to the Vehicle.
- 2.6 The Vehicle must not be used in any stunts of any kind.
- 2.7 The Vehicle must not be used for doughnuts or other displays of excessive stress on the Vehicle.
- 2.8 The Vehicle must not be driven in such a manner that any of its tyres lose contact with the surface of the road or other area where it is being driven at any time.
- 2.9 No persons should be put in danger in any way while the Vehicle is the subject of the Use.

#### **3.0 RULES REGARDING THE VEHICLE**

# Capture Classics

- 3.1 The Vehicle must not be altered mechanically in any way.
- 3.2 The Vehicle must not be painted or the interior trim changed in any way.
- 3.3 The external and internal appearance of the Vehicle must not be altered in any way.
- 3.4 Any cameras or other equipment fitted to the Vehicle must not damage or alter in any way any part of the Vehicle and must be removable and removed without any such damage or alteration.
- 3.5 The wheels and tyres which are on the Vehicle when it is delivered must not be removed and replaced at any time.
- 3.6 Neither the registration number nor the chassis plate of the Vehicle must be shown in the Production or any media or promotional material associated with the Production.
- 3.7 When the Vehicle is parked (even for a short period), the steering lock supplied with the Vehicle must be securely fitted.
- 3.8 If the Licence Period involves the Vehicle being retained by the Hirer overnight:
  - 3.8.1 the Vehicle must be stored in a secure place with all locks locked;
  - 3.8.2 the steering lock must be securely fitted;
  - 3.8.3 any alarms fitted to the Vehicle must be activated;
  - 3.8.4 any ignition cut-off fitted to the Vehicle must be activated;
  - 3.8.5 the Vehicle must be stored off the public highway and under cover;
  - 3.8.6 any security personnel on site overnight must be alerted to the presence of the Vehicle and be able to move it in the event of any fire in its vicinity.

## 4.0 RULES REGARDING THE DRIVER

- 4.1 Any person driving the Vehicle or handling it in any way must read all of these Rules before doing so.
- 4.2 No person, whose eyesight requires correction, shall drive the car unless they wear suitable corrective eyewear while driving the Vehicle.
- 4.3 The Vehicle must only be used by a driver who has experience of driving and manoeuvring a vehicle of similar age and type as the Vehicle.
- 4.4 No person must be allowed to drive the Vehicle unless the driver has a full United Kingdom driving licence with no unexpired convictions for any motoring offence.
- 4.5 No person under the age of 25 shall drive the vehicle.
